*N*OTICE IS HEREWITH GIVEN THAT THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, WILL CONDUCT A PUBLIC HEARING ON THE FOLLOWING TO CERTIFY THE NON-AD VALOREM FINAL ASSESSMENT ROLL FOR THE RE-IMPOSITION OF ANNUAL SPECIAL ASSESSMENTS FOR THE **SAFE NEIGHBORHOOD IMPROVEMENT DISTRICT FEES** TO THE DESIGNATED DISTRICT AREAS WITHIN THE CITY OF LAUDERHILL IN ONE LUMP SUM ON THE BROWARD COUNTY ANNUAL TAX BILL FOR THE FISCAL YEAR BEGINNING **OCTOBER 1, 2017** AND ANNUALLY THEREAFTER FOR THE COLLECTION OF ALL ASSOCIATED COSTS AND EXPENSES ONLY TO APPLY TO THE DESIGNATED DISTRICT IMPROVEMENT AREA WHERE THERE IS A PLAN TO REDUCE CRIME THROUGH ENVIRONMENTAL DESIGN, ENVIRONMENTAL SECURITY, OR DEFENSIBLE SPACE TECHNIQUES, OR THROUGH COMMUNITY POLICING INNOVATIONS.



FOR THIS PURPOSE, MEMBERS OF THE PUBLIC WILL BE ALLOTTED THREE (3) MINUTES EACH FOR COMMENT AT EACH MEETING.
