UTILITY RECONNECTION/DISCONNECTION

If water service is disconnected for non-payment, a disconnection/reconnection service charge of \$50.00 will be applied to your next bill. Payments to reconnect service must be received by 6:00 pm on the same day. Payment received after 6:00 pm will be reconnected by the end of the next business day.

CHECKING WATER LEAKS

Water leaks can be costly to a homeowner; your eyes and ears can easily see or hear some leaks. The most common leak is the toilet. It can leak up to an average of 22 thousand gallons.

ADJUSTMENTS

The City of Lauderhill does not give credit/adjustments for toilets or faucet damage. If you find that you have a leak on your property, the City of Lauderhill can help alleviate a portion of the wasted sewer by giving one leak adjustment per calendar year, if applicable. The customer must provide a copy of plumber's receipt for the repairs. This should include a description of the problem and the date of the repair. We will then use a six months prior average to calculate the adjustment amount.

The rate structure is a tiered structure designed to reward water conservation. The less water you use, the less you are charged per gallon on water consumption.
