City of Lauderhill is projected to receive \$285,000 from Florida Housing Finance Corporation Coronavirus Relief Fund (CRF) for FY 2019/2020 to be made available for the period of March 1, 2020 To December 31, 2020 to provide rental, mortgage, homeowner association fees and/or utility assistance.

Summary of Strategies

RENTAL ASSISTANCE

up to \$10,000

Funds can be awarded for rent payments to avoid eviction due to certified COVID-19 income hardships for City of Lauderhill residents meeting 120% and below of Broward County's Adjusted Median Income as published by Florida Finance Housing Corporation.

MORTGAGE AND HOMEOWNER ASSOCIATION FEE ASSISTANCE

up to \$10,000

Funds can be awarded for HOA fees and/or mortgage payments to avoid foreclosure proceedings due to certified COVID-19 income hardships for City of Lauderhill residents meeting 120% and below of Broward County's Adjusted Median Income as published by Florida Finance Housing Corporation.

UTILITY ASSISTANCE

up to \$5,000

Funds can be awarded for utility, including electric, water or gas, payments to avoid service disruptions due to certified COVID-19 income hardships for City of Lauderhill residents meeting 120% and below of Broward County's Adjusted Median Income as published by Florida Finance Housing Corporation.

Please note, some applicants may not be assisted due to limited funding availability.

Eligibility Criteria

Applicants must complete FHFC-CRF application in full and meet income requirements in order to be considered for assistance. Incomplete applications will not be accepted.
