

CITY OF LAUDERHILL
DECLARATION OF STATE OF EMERGENCY
(SOE 21-05 Forty-ninth COVID 7-Day Extension)

WHEREAS, on March 9, 2020 at 5:52 p.m., Governor Ron DeSantis issued Executive Order Number 20-52 activating the Florida Comprehensive Emergency Management Plan and declaring that a State of Emergency exists in the State of Florida, which was extended thereafter and remains in effect; and

WHEREAS, the Broward County Board of County Commissioners issued a Declaration of Emergency declaring Broward County under a Local State of Emergency on March 10, 2020 at 12:25 p.m.; and

WHEREAS, on March 2, 2020 at 11:30 a.m., the City of Lauderhill declared a State of Emergency as to the Public Health Emergency (hereinafter referred to as SOE 20-01); and

WHEREAS, on March 10, 2020 at 2:40 p.m., the City of Lauderhill declared an actual State of Emergency (hereinafter referred to as SOE 20-02), based upon the Governor's Executive Order Number 20-52; and

WHEREAS, pursuant to Section 8½ - 3(c), declarations of a state of emergency shall be for a period of time not to exceed seven (7) days at a time and may be extended for additional periods of time not to exceed seven (7) day increments; and

WHEREAS, thereafter the City of Lauderhill has continuously issued seven (7) day extensions of the Declaration of a State of Emergency regarding COVID-19 throughout the remainder of 2020 and has already issued two orders in 2021; and

WHEREAS, on January 19, 2021, at 3:53 p.m., the City of Lauderhill declared the forty-fifth weekly extension of the State of Emergency (SOE 21-01) regarding COVID in the City of Lauderhill effective through January 26, 2021; and

WHEREAS, on January 26, 2021, at 8:00 a.m., the City of Lauderhill declared the forty-sixth weekly extension of the State of Emergency (SOE 21-02) regarding COVID in the City of Lauderhill effective through February 2, 2021; and

WHEREAS, on February 2, 2021, at 1:20 p.m., the City of Lauderhill declared the forty-seventh weekly extension of the State of Emergency (SOE 21-03) regarding COVID in the City of Lauderhill effective through February 9, 2021; and

WHEREAS, on February 9, 2021, at 4:55 p.m., the City of Lauderhill declared the forty-eighth weekly extension of the State of Emergency (SOE 21-04) regarding COVID in the City of Lauderhill effective through February 16, 2021; and


