

**CITY OF LAUDERHILL
DECLARATION OF STATE OF EMERGENCY
(SOE 21-24 Sixty-eighth COVID 7-Day Extension)**

WHEREAS, on March 9, 2020 at 5:52 p.m., Governor Ron DeSantis issued Executive Order Number 20-52 activating the Florida Comprehensive Emergency Management Plan and declaring that a State of Emergency exists in the State of Florida, which was extended thereafter and remains in effect; and

WHEREAS, the Broward County Board of County Commissioners issued a Declaration of Emergency declaring Broward County under a Local State of Emergency on March 10, 2020 at 12:25 p.m.; and

WHEREAS, on March 2, 2020 at 11:30 a.m., the City of Lauderhill declared a State of Emergency as to the Public Health Emergency (hereinafter referred to as SOE 20-01); and

WHEREAS, on March 10, 2020 at 2:40 p.m., the City of Lauderhill declared an actual State of Emergency (hereinafter referred to as SOE 20-02), based upon the Governor's Executive Order Number 20-52; and

WHEREAS, pursuant to Section 8½ - 3(c), declarations of a state of emergency shall be for a period of time not to exceed seven (7) days at a time and may be extended for additional periods of time not to exceed seven (7) day increments; and

WHEREAS, thereafter the City of Lauderhill has continuously issued seven (7) day extensions of the Declaration of a State of Emergency regarding COVID-19 throughout the remainder of 2020 and has already issued two orders in 2021; and

WHEREAS, on January 19, 2021, at 3:53 p.m., the City of Lauderhill declared the forty-fifth weekly extension of the State of Emergency (SOE 21-01) regarding COVID in the City of Lauderhill effective through January 26, 2021; and

WHEREAS, on January 26, 2021, at 8:00 a.m., the City of Lauderhill declared the forty-sixth weekly extension of the State of Emergency (SOE 21-02) regarding COVID in the City of Lauderhill effective through February 2, 2021; and

WHEREAS, on February 2, 2021, at 1:20 p.m., the City of Lauderhill declared the forty-seventh weekly extension of the State of Emergency (SOE 21-03) regarding COVID in the City of Lauderhill effective through February 9, 2021; and

WHEREAS, on February 9, 2021, at 4:55 p.m., the City of Lauderhill declared the forty-eighth weekly extension of the State of Emergency (SOE 21-04) regarding COVID in the City of Lauderhill effective through February 16, 2021; and

WHEREAS, on March 9, 2021, at 8:00 a.m., the City of Lauderhill declared the fifty-second weekly extension of the State of Emergency (SOE 21-08) regarding COVID in the City of Lauderhill effective through March 16, 2021; and

WHEREAS, on March 16, 2021, at 2:25 p.m. the City of Lauderhill declared the fifty-third weekly extension of the State of Emergency (SOE 21-09) regarding COVID in the City of Lauderhill effective through March 23, 2021; and

WHEREAS, on March 23, 2021, at 10:00 a.m., the City of Lauderhill declared the fifty-fourth weekly extension of the State of Emergency (SOE 21-10) regarding COVID in the City of Lauderhill effective through March 30, 2021; and

WHEREAS, on March 30, 2021, at 8:00 a.m., the City of Lauderhill declared the fifty-fifth weekly extension of the State of Emergency (SOE 21-11) regarding COVID in the City of Lauderhill effective through April 6, 2021; and

WHEREAS, on April 6, 2021, at 9:00 a.m., the City of Lauderhill declared the fifty-sixth weekly extension of the State of Emergency (SOE 21-12) regarding COVID in the City of Lauderhill effective through April 13, 2021; and

WHEREAS, on April 13, 2021, at 9:00 a.m., the City of Lauderhill declared the fifty-seventh weekly extension of the State of Emergency (SOE 21-13) regarding COVID in the City of Lauderhill effective through April 20, 2021; and

WHEREAS, on April 20, 2021, at 4:00 p.m., the City of Lauderhill declared the fifty-eighth weekly extension of the State of Emergency (SOE 21-14) regarding COVID in the City of Lauderhill effective through April 27, 2021; and

WHEREAS, on April 27, 2021, at 11:30 a.m., the City of Lauderhill declared the fifty-ninth weekly extension of the State of Emergency (SOE 21-15) regarding COVID in the City of Lauderhill effective through May 4, 2021; and

WHEREAS, on May 4, 2021, at 2:50 p.m., the City of Lauderhill declared the sixtieth weekly extension of the State of Emergency (SOE 21-16) regarding COVID in the City of Lauderhill effective through May 11, 2021; and

WHEREAS, on May 11, 2021, at 11:45 a.m., the City of Lauderhill declared the sixty-first weekly extension of the State of Emergency (SOE 21-17) regarding COVID in the City of Lauderhill effective through May 18, 2021; and

WHEREAS, on May 18, 2021, at 1:50 p.m., the City of Lauderhill declared the sixty-second weekly extension of the State of Emergency (SOE 21-18) regarding COVID in the City of Lauderhill effective through May 25, 2021; and

WHEREAS, on May 25, 2021, at 1:40 p.m., the City of Lauderhill declared the sixty-third weekly extension of the State of Emergency (SOE 21-19) regarding COVID in the City of Lauderhill effective through June 1, 2021; and

WHEREAS, on June 1, 2021, at 11:00 a.m., the City of Lauderhill declared the sixty-fourth weekly extension of the State of Emergency (SOE 21-20) regarding COVID in the City of Lauderhill effective through June 8, 2021; and

WHEREAS, on June 8, 2021, at 9:00 a.m., the City of Lauderhill declared the sixty-fifth weekly extension of the State of Emergency (SOE 21-21) regarding COVID in the City of Lauderhill effective through June 15, 2021; and

WHEREAS, on June 15, 2021, at 12:10 p.m., the City of Lauderhill declared the sixty-sixth weekly extension of the State of Emergency (SOE 21-22) regarding COVID in the City of Lauderhill effective through June 22, 2021; and

WHEREAS, on June 22, 2021, at 14:04 p.m., the City of Lauderhill declared the sixty-seventh weekly extension of the State of Emergency (SOE 21-23) regarding COVID in the City of Lauderhill effective through June 29, 2021; and

WHEREAS, this SOE 21-24 continues to extend the Declaration of a State of Emergency regarding COVID for the sixty-eighth seven (7) day extension of the Declaration of a State of Emergency in the City of Lauderhill; and

NOW, THEREFORE, I, Desorae Giles-Smith, the City Manager of the City of Lauderhill, effective at 10:00 a.m/p.m. on Tuesday, June 29, 2021, do hereby extend the declaration of a STATE OF EMERGENCY which exists in the City of Lauderhill for the sixty-eighth seven (7) day extension through July 6, 2021, unless otherwise terminated or extended.
