NOTICE IS GIVEN that a draft of the **PY 2023 Consolidated Annual Performance and Evaluation Report (CAPER) for The City of Lauderhill** has been completed and will be available for a 15-day public review period. Notice is also given that there will be a public hearing to discuss the draft CAPER.

The CAPER reports on accomplishments and expenditures for the City's Community Development Block Grant (CDBG) program, as required by the U.S. Department of Housing and Urban Development (HUD) during the 2023 program year from October 1, 2023 through September 30, 2024. In PY 2023, the resources made available for the CDBG program was \$700,973.

PUBLIC COMMENT PERIOD: Citizens and interested parties are invited to review and make comments on the draft CAPER. The draft CAPER is available for (15) fifteen days, beginning November 18, 2024 to December 2, 2024.
